- Shaw Sports Turf Momentum HP 2.0 Furnish and install Momentum HP 2.0. Momentum HP 2.0 is 2" slit film product with 41 ounces of face weight per square yard.
- Turf Layout Turf will be laid across the building in all green or purple with 4" tufted white lines (5-Yard lines) every 30' including a 15' Power P logo in purple or white or a combination.
- Turf seams will be adhered.
- Power P Logo Furnish and install a 15' tall P in purple with a 4" white border or white w/purple border.
- Turf Infill 100% rubber
- Maintenance Device Furnish a Redexim Vbroom WB groomer for Owner's routine Maintenance.
- Care & Maintenance Training Provide care and maintenance training for staff.
- GMAX Test Perform an ASTM F-1936 GMAX impact test upon completion of the project. Owner will receive report within 5 days.
- 8 Year Warranty 8-year warranty on workmanship and defects provided on the synthetic turf provided by Shaw Sports Turf.
- Cleanup Cleanup all areas disturbed upon completion.
